Cover Letter	PHS_Cover_Letter	Is accessible only to appropriate NIH staff, but not peer reviewers. For mentored CDA applications, cover letter must contain the same list of Referees (with name, departmental affiliation, and institution) that is included in the Other Project Information/Other Attachment. Encouraged by NIH for all applications; see instructions. Required for changed/corrected applications submitted after the deadline and to provide any approvals required by the FOA

### FONT AND MARGIN SPECIFICATIONS:

Use an Arial, Helvetica, Palatino Linotype, or Georgia typeface, a black font color, and a font size of 11 points or larger. (A Symbol font may be used to insert Greek letters or special characters; the font size requirement still applies.)

Type density, including characters and spaces, must be no more than 15 characters per inch.

Type may be no more than six lines per inch.

Use at least one-half inch margins (top, bottom, left, and right) for all pages. No information should appear in the margins (header and footer), including the PI's name and page numbers.

Before applying for a K award, applicants should carefully review the applicable FOA for the career award of interest, noting especially the eligibility requirements, requirements for a mentor, review criteria, award provisions, and any special application instructions. **PAGE LIMITS: Follow page limitations as specified in Funding Opportunity Announcements (FOA). Generally,** The total number of pages for the following items combined may not exceed 12 pages: Candidate's Background, Career Goals and Objectives, Career Development/Training Activities During Award Period, Training in the Responsible Conduct of Research, and Research Strategy).

Other page limits are noted in the table.
