Bibliography & References Cited	Bibliography	For publicly available citations, URLs or PMC submission identification numbers may accompany the full reference

Additional Narrative Justification	PHS_ModBud_NarrativeJustif	Required for modular budgets that have a variance in the number of modules requested per budget year
Budget Justification	Budget_Justification	Required for all detailed budgets
