RE: Implementation of New Fringe Benefit Rate Agreement

The University has successfully negotiated a new Fringe Benefit cost rate with the federal government. The official rate agreement has been finalized and posted at: http://www.umaryland.edu/cost/fringe-benefit/

Please note that the finalized faculty and staff rates differ slightly from the rates we originally communicated to campus through the <u>FY18 Fringe Benefit Planning Rate Announcement</u>. In summary, the rates effective 07/01/2017 through 06/30/2018 are as follows:

The following salary accounts will not incur fringe benefits due to the student FICA exemption:

- 1020 Graduate Assistants
- 2074 Student College Work Study (CWS)
- 2075 Students other than CWS

If it is determined that these employees are not eligible for the FICA exemption during the summer, then the Legislated Benefit rate above will be applied to these summer wages.

These rates should now be used for all grant and contract proposals and for planning purposes on nonsponsored funding sources. Kuali COEUS has been updated to reflect these new rates.
