**Extension of F&A Rates through 2021** 

The University has successfully negotiated a new agreement for F&A and Fringe Benefit costs with the federal government. The official rate agreement has been finalized and posted at:

The current F&A rates\_were extended through FY2021.

The new Fringe Benefit Rates were approved per the summary below. These rates are effective 07/01/2018 through 06/30/2019.

The following salary accounts will not incur fringe benefits due to the student FICA exemption:

- 1020 Graduate Assistants
- 2074 Student College Work Study (CWS)
- 2075 Students other than CWS

If it is determined that these employees are not eligible for the FICA exemption during the summer, then the Legislated Benefit rate above will be applied to these summer wages.

These rates should now be used for all grant and contract proposals and for planning purposes on nonsponsored funding sources. Kuali COEUS has been updated to reflect these new rates.
