The User Security Roles (QFN071) Report should be used to identify the Quantum Financials roles held by employees and affiliates. It can be run at any time, but should be run whenever employees or affiliates terminate or change jobs to help ensure roles are properly removed. It must be run at least annually as part of the role validation required by USM IT Security Standards. The User Security Roles PDF report option should be used for the annual role validation. Role validation instructions can be found <u>here</u>.

- 1. Open Quantum Financials.
- 2. Navigate to Reports > User Security Roles (QFN071) Report



3. The report can be run based on the selection from several prompts. Commonly used selections include School, Department, Organization, Person Number, and Role. One or multiple values can be entered in each prompt. The default for each prompt is "All" and if not changed, will return otherwise unfiltered results. Once selections are made, click Apply to run the report.



- If you want your results to show all employees in a Department Search for and select the Department name and leave all other prompts as All. Click Apply.
- If you want your results to show all employees in multiple Organizations Search for and select the Org numbers and leave all other prompts as All. Click Apply.

- If you want your results to show all assigned roles for an individual employee Search for and select the employee's EMPL ID # and leave all other prompts as All. Click Apply.
- 4. To download the report results to Excel for further evaluation, select the **Gear icon** at the top right side of the navigation area and select Export > Excel.



5. Open the Excel download and Enable Editing. The report contains the following headers:
