MSCHE Feedback from 2016 Site Visit

The MSCHE Site Visit Team made two suggestions relating to assessment, one of which is below (as of May 2016):

Standard 7: *Institutional Assessment*. The team suggests that **UMB** periodically evaluate the effectiveness and comprehensiveness of its institutional assessment processes.

What this guidance means (MSCHE, 2007):

- Define and articulate institutional and unit goals;
- Implement strategies to achieve those goals;
- Assess achievement of those goals;
- Use results to improve programs and services, and inform planning and resource allocation.

Documentation of Assessment Practices

Program Assessment

- Institutional/departmental policies and procedures/expectations for program review.
- Curriculum maps demonstrating progression in achievement of program-level outcomes.
- Program assessment plans.
- Evidence of discussion of program review results and consequent action plans for program improvement, enhancement, and/or innovation.
- Evidence of emphasis on direct assessment methods.

Planning Phase Expectations

- Enter an Assessment Plan for each degree program or certificated program that is externally accredited;
 - General Information
 - Areas needing improvement
 - Up to three goals to attain in the current fiscal year (FY2021) and associated metrics to report on progress.

Legend/Definitions

Student Learning Objective (SLO) Goals that address what students will know upon completion of program

Student Other (SO) Goals that address improving pass rates, retention, graduates rates, etc.

Program Operation (PO) Goals that address marketing of programs, new program development, recruitment, etc.

Other (O) Goals not clearly defined or missing metrics



Questions Arising During Plan Phase

- Is it appropriate to include goals for a graduating class that won't graduate for another two years?
- Are operational goals allowable?
- Are APAIRs required for certificate programs? Can these APAIRs be combined?
- What unit is responsible for providing the APAIR(s) for programs in the Graduate School that are affiliated with other UMB schools?
- How to treat dual programs with USM institutions?



Goal Writing Suggestions

- Goals need to be attainable in the APAIR year
 - Incorrect: "Graduate an XXX cohort of 30 students in 2022 and 40 students in 2023."
 - Correct: For the class of 2022 and all subsequent cohorts, involve 100% of students in faculty-directed research for 15 hours per semester as part of the fall and spring curriculum in the second program year. For the class of 2022, the target completion date would be May 2021 and this would be a recurring goal for subsequent cohorts.

Performance period ends	June 30, 2021
APAIR due	December 31, 2021 (6 months after beginning of reporting period)

Documentation of Assessment Practices

Institutional Learning Outcomes Assessment

- Identification of institutional learning outcomes and multiple learning opportunities to learn the skills needed for assessment.
- Evidence of consistent involvement across all departments/programs.
- Evidence of discussion of institutional learning outcomes assessment results and consequent action plans for revision, improvement, enhancement, and/or innovation.
- Evidence of use of direct assessment methods.

Plan for UMB Institutional Learning Outcomes

- 2022 2026 Strategic Plan planning process commences January / February 2021
- A strategic outcome will be the identification of institutional learning outcomes for all UMB students and devising a plan to develop and implement a process to assess their attainment
- Suggested institutional learning outcomes include the demonstration of competencies in these areas:
 - Inter-Professional Education
 - Community Engagement
 - Global Health
 - Leadership
 - Diversity, Equity, and Inclusion
- The APAIR could be expanded to facilitate and document assessment of institutional learning outcomes
