

- –Program Leadership/ Demographics
- Degree/Certificates covered in Plan
- –Area(s) of Improvement needed
- –Goals to address improvements
- -Results reporting

<u>Annual Program</u> <u>Assessment Plan Module</u>

- IESPA-preloaded data
 - UMB-approved degree and certificates Primary School affiliation
 - Secondary School affiliation, if applicable
 - HEGIS and CIP codes
- Unit-provided data*
 - Program Leadership
 - Program Performance Indicators (PPI)

*Year-to-Year carryover is possible

<u>Annual Program</u> <u>Assessment Plan Module</u>

- Will define goals by type
 - Institutional Learning Outcome (ILO)
 - Student Learning Outcome (SLO)
 - Program Performance Indicator (PPI)
 - Program Operations (PO)
 - Other (None of the above)
- Access categories: Contributor(s);
 Approver required; View only
- Evidence Inventory
- Comments

Institutional Learning Outcomes Management (ILO) Module

- IESPA-preloaded data
 - Themes and Objectives
- Required: for each theme
 - Highest objective achieved
 - Select proposed status in FY (e.g., maintain, advance)

Institutional Learning Outcomes Module

- Ability to link annual goals if ILO-related
- Evidence of achievement
 - Evidence: add, delete functionality (auto datestamped)
 - File upload (numerous file types)
 - Note: No need to upload the same file multiple times
- Comments (Optional)

External Program Review Management Module

- Required Fields
 - Program Review Status (Fullyapproved/accredited/recertified; Program Action; Program-Suspended; Program Discontinued)
 - Program Reviewer: USM or Other
 - External Review Organization
 Name (if other)
 - Date of Last Review
 - Review Outcome
 - Next Anticipated Review Year

External Program Review Management Module

- IESPA-Provided
 - Reminders as review date approaches
 - Repository for evidence

APAIR Due Dates*



FY Academic Planning

(July 1, 20xx- June 30, 20xx)

Program review and goal-setting closes: July 1 - September 30

Progress reporting closes September 30 of the following fiscal year (e.g., FY23 – July 1 – June 30, 2023; Annual report due September 30, 2023*)

*Exception – PPI Data due December 31, 2023



APAIR Implementation 2.0

- Transferring APAIRs to In-house system
 - May/June 2023 (projected completion date)
 - Pilot and resolve system issues (May/June 2023)
 - Implementation and Roll-out (July 2023)
