Dr. Dillingham has led the development of global health training across the schools at UVA through the UVA Framework Program in Global Health, an initiative supported by the Fogarty International Center. In addition to sustained funding through the Framework program, Dr. Dillingham leads three other NIH-funded international research training grants. After receiving her undergraduate degree, Dr. Dillingham traveled to the Ivory Coast to work on HIV prevention for two years prior to entering medical school. She trained in internal medicine and infectious diseases at UVA. Dr. Dillingham has been awarded numerous teaching and clinical service awards in recognition of her skill as an educator as well as her humanistic approach to medicine. Her major clinical activity is the care of adult patients infected with HIV. Dr. Dillingham's funded research projects include the use of cell phone-based technology to help vulnerable populations improve engagement in HIV care and the evaluation of the impact of changes in water and sanitation on the incidence of water-borne disease.
