



## University Student Financial Assistance

### 2019-2020 Estimated Cost of Attendance and Financial Aid

#### *University of Maryland Carey School of Law*

Applicants needing federal and institutional financial assistance to help with the cost of attending a school or program at UMB must complete the **Free Application for Federal Aid (FAFSA)**. Please note:

- Beginning with the 2018-2019 year, the FAFSA becomes available October 1<sup>st</sup>. USFA strongly encourages completing the FAFSA no later than March 1<sup>st</sup> for priority consideration
- The 2019-2020 FAFSA covers the 2019-2020 Academic Year (Summer 2019, Fall 2019 and Spring 2020)
- Students must complete a FAFSA for every academic year they wish to receive assistance

#### **Estimated Cost of Attendance**

The Cost of Attendance (COA) is the maximum amount of financial assistance available to a student in one academic year. The COA is determined using each student's enrollment (Day or Evening) and residency classification (Resident or Non-Resident).
