## 1. General Dentist

**Job Summary:** Provide preventive dental care and instruction. Perform general dental hygiene duties to include periodic recalls, scaling/root planning, and sealant placement. Perform all needed services for offsite screening/sealants to include oral hygiene instructions, screening examinations, referral coordination. Supervise dental assistant and work with dental office managers to provide and ensure continuation and follow up of care.

## 2. Community Outreach Social Worker

**Job Summary:** The position provides direct patient care in the Brightbill Specialty Practice and will give direct psychological, social and practical care to a select caseload of patients and families including social work assessments, problem identification, goal setting and implementation of care plans. Makes referrals to outside agencies and coordinates continuity of care. Provides critical services that enables patients to enter and maintain medical care to treat their HIV/AIDS diagnosis. Works collaboratively with the multidisciplinary team to optimize patient outcomes and contribute to the attainment of organizational goals.

### 3. Associated General Legal Advisor

**Job Summary:** The Associate General Legal Advisor will be responsible for providing guidance, direction, and assistance in connection with a wide variety of legal matters to and on behalf of the organization, including a myriad of commercial as well as a broad range of health care regulatory matters. Representing and advocating for the organization and its subsidiaries in dealings with third parties in business and healthcare ventures. Drafting, reviewing and negotiating commercial agreements with employees, vendors and other business partners. Providing real-time and ongoing assistance to operations personnel with regard to legal issues (including participating in an on-call rotation after appropriate training). Working collaboratively with executive leadership.

#### 4. General Care Nurse

**Job Summary:** The General Care Nurse is involved in direct and indirect patient care. The RN provides direction to licensed vocational nurses (LVNs) and other non-licensed nursing personnel in providing direct patient care. The General Care Nurse supports the medical care of patients under the direction of the Medical Staff pursuant to the objectives of the hospital. In collaboration with other health team members, follows the philosophy, policies and goals of the facility and department.

#### 5. Clinical Pharmacist

**Job Summary:** The Clinical Pharmacist is responsible for providing comprehensive pharmaceutical care for adult and pediatric patients. The daily clinical functions include but are not limited to: Verifies the accuracy of order entry by authorized prescribers in computerized patient medication profiles. Reviews written/electronic medication orders or prescriptions to determine appropriate ingredients, strength, and dosage. Reviews medication orders for: potential allergies, drug/drug and food/drug interactions, route of administration, appropriate dose and potential for adverse drug reactions with other medications ordered.

#### 6. Infectious Disease Physician

**Job Summary:** The Infectious Disease Physician provides direct care and supervision of patients suffering from various infectious diseases. In their work, they will work directly with hospital staff and provide high-quality patient care. In addition to serving as the primary clinical consultant in infectious disease, this physician keeps staff clinicians abreast of developments in treatment techniques and actively pursues opportunities to further develop and improve the care that the organization provides.

#### 7. Researcher: Level 1

**Job Summary:** The selected candidate will investigate the products of a new HIV-1 gene, and will elucidate their role in viral replication and persistence using both in vitro and in vivo models. Moreover, the candidate will contribute to develop a gene therapy-based approach to achieve a functional cure for HIV-1.
