

# H-4 FAQs and Legal Resources

This resource provides general information about two USCIS forms and filing procedures for H-4 dependent benefits:

1. Form I-539 to change to or extend H-4 status; and
2. Form I-765 to apply for H-4 work authorization.

## WHEN CAN MY H-4 DEPENDENTS FILE THE I-539?

The H-4 application may be filed when your H-1B petition is received by USCIS. Please see the email from OIS that provided you with the link to this resource for further information.

## SHOULD MY DEPENDENTS FILE THEIR I-539S ELECTRONICALLY OR BY MAIL?

If there is just one dependent, online filing is less expensive than filing by mail. See eligibility at: <https://www.uscis.gov/i539online>

- **Please note:** If your spouse wishes to file an application for H-4 work authorization at the same time as their I-539, they are required to file by mail. The work authorization application is not available online for H-4 applicants.

**If you have multiple dependents** who need to file applications, submitting the application by mail is less expensive, as you will be able to include all H-4 dependents on a single application with one filing fee.

- See the USCIS instructions regarding the use of form I-539A, which allows you to list all your H-4 dependents.

## **IS MY SPOUSE ELIGIBLE TO APPLY FOR WORK AUTHORIZATION?**

H-4 spouses (not children) are eligible for work authorization only if the H-1B principal:

- Has an approved Form I-140, or
- Is granted H-1B extensions under AC21 sections 106(a) and (b)

Contact OIS if you are uncertain.

## **HOW DOES MY SPOUSE APPLY FOR WORK AUTHORIZATION?**

Qualifying H-4 applicants file Form I-765 under category (c)(26).

## **WHAT DOCUMENTS NEED TO BE INCLUDED WITH THE I-539?**

Generally, your dependents will be required to include:

- **Payment** of the I-539 fee
- **Receipt notice for your most recent H-1B filing**
- **Proof of relationship to you:** Marriage certificate (for spouse) or birth certificate (for children)
  - Certified English translations for any non-English documents.

- **Dependent's Identity and Immigration Status Documents:**
  - Valid passport (identification and expiration page(s))
  - Copy of visa stamp in passport
  - Most recent form I-94
  - Relevant immigration documents (e.g., F-2 I-20, J-2 DS-2019, prior H-4 I-797 approval notices)
- **Identity and Immigration Status Documentation of principal H-1B:**
  - Valid passport (identification and expiration page(s))
  - Copy of visa stamp in passport
  - Most recent form I-94
  - Relevant immigration documents (e.g., F-1 I-20, J-1 DS-2019, prior H-1B I-797 approval notices)
- If applicable:
  - Copy of I-612 waiver of two-year home residency requirement
  - Copy of documents related to permanent residency applications
  - Copy of previously issued EADs

# IMMIGRATION LEGAL RESOURCES

UMB recognizes that some international students or scholars may have specific questions about their status that is beyond the expertise of UMB and campus officials. The following resources can help students and scholars find competent legal representation (sometimes at low or no cost):

**Do I Really Need a Lawyer?** - Before contacting a lawyer regarding an immigration issue,

- Speak with your OIS adviser to confirm that your questions are about immigration issues.
- Visit the US Citizenship and Immigration Service (USCIS) (<https://www.uscis.gov/>) website where you will find answers to many of your questions.

**How Do I Choose a Lawyer?**

- Before choosing a lawyer, call the offices of the lawyers on your list, briefly explain your legal problem and ask:
  - Are you specialized and/or experienced in my type of problem?
  - Do you charge a flat rate or hourly fee for this type of work?
  - Can you give me an estimate of the cost?
  - Can you estimate the amount of time it will take?

**Consider the following factors before agreeing to hire a lawyer:**

- Can you communicate effectively with the lawyer? Was the lawyer clear and easy to understand? Are the fees reasonable in comparison with other lawyers' charges?
- Did the lawyer clearly explain how she or he will keep you informed of progress in your case?
- If you are not satisfied with this lawyer, do not hire him or her. Look elsewhere for legal help.
- Before you finally sign a contract with a lawyer, read it carefully. Make sure you understand it.
- Everything you and the lawyer agreed to should be in writing.
