ADVERTISING YOUR STUDY

Please ensure that all recruitment materials include the following elements:

- Principal Investigator's (PI) name
- Protocol number
- Study title
- Brief, lay summary of the study's purpose
- Basic eligibility criteria
- Contact information for questions or enrollment
- · Statement indicating the study involves research
- IRB approval or submission reference (if applicable)

These elements help ensure that recruitment materials are clear, informative, and compliant with regulatory expectations.

Pls who have protocols that were reviewed at full board meetings are encouraged to submit CRs at least eight (8) weeks prior to expiration of IRB approval.
